6. GSA Spotlight Presentation – Oakdale Irrigation District

Alternate Eric Thorburn shared the details of his presentation. Some highlights included:

- Pre-1914 Water and Post, 1914 Storage Rights on the Stanislaus River
- On-farm irrigation: mixture of gravity flow and micro-drip irrigation
- Some challenges have been long term water supply, aging infrastructure and land use changes.
- Future plans include protection of OID's water rights and fund improvements without raising rates.
