**Board Meeting Minutes**  
**October 14, 2020**

**I. Call to Order/Pledge of Allegiance & Safety Announcement/Roll Call**

The Eastern San Joaquin Groundwater Authority (GWA) Board Teleconference meeting convened and Vice Chairman Mel Panizza called the meeting to order in the absence of Chairman Chuck Winn, via the online Microsoft Teams Meeting platform, at 10:38 a.m. on October 14, 2020. The meeting was conducted via Teleconference only.

Chairman Winn joined the meeting and continued to lead the agenda.

Mrs. Kristy Smith with San Joaquin County conducted the roll call.

In attendance were Chairman Chuck Winn; Vice Chairman Mel Panizza; Secretary Fritz Buchman; Directors David Breitenbucher, David Fletcher, Mike Henry, Tom Flinn, Eric Thorburn, John Herrick, Robert Holmes; Alternate Directors Reid Roberts, Charlie Swimley, Walter Ward. Director Dan Wright was in attendance, and arrived after the meeting called to order.

**II. SCHEDULED ITEMS**

**A. Action Items:**

**1. Approval of Minutes of August 12, 2020**

Chairman Winn called for the approval of minutes of the meeting on August 12, 2020. There were no comments by the GWA Board members and no comments by the public.

**Motion:**

Director Mike Henry moved, and Alternate Director Reid Roberts second, approval of the August 12, 2020 minutes. Chairman Winn conducted a verbal vote. With none opposed, the motion passed unanimously.

**2. Resolution Authorizing the Secretary of the Eastern San Joaquin Groundwater Authority to Approve Expenditures and Execute Contracts Within the Designations and Limitations of the Approved Budget Resolution.**

Mr. Matt Zidar with San Joaquin County provided a brief overview of the Resolution before the Board, previously discussed and approved for recommendation at the Steering Committee level.

**Motion:**

Alternate Director Charlie Swimley moved, and Alternate Director David Breitenbucher second, to approved the proposed. Chairman Winn conducted a verbal vote. With none opposed, the motion passed unanimously.

**3. DWR Draft GSP Project Proposal Solicitation Package – Discussion of Approach to Project Selection.**

Mr. Matt Zidar with San Joaquin County provided an overview of the DWR Draft GSP Project Proposal Solicitation Package. Mr. Zidar advised that Stockton East Water District (SEWD) could not wait for Grant funding and would be proceeding with their project, leaving two projects from North San Joaquin Water

Conservation District (NSJWCD). The floor was given to Ms. Jennifer Spaletta, representative for NSJWCD, to provide an overview of their proposed projects for inclusion in the DWR Grant Application.

Ms. Jennifer Spaletta provided details on the two NSJWCD projects, including timeline, financial and cost share details. Ms. Spaletta discussed NSJWCD's existing South System Rehabilitation Project, providing details on project components already completed, estimated costs and additional project components. Ms. Spaletta advised that NSJWCD already has a 3 million dollar grant allocated to this South System Project and additional funds would bring the project pretty far along before beginning their other project on the North System. Ms. Spaletta presented NSJWCD's North System Rehabilitation Project as the second option for funding. Ms. Spaletta provided details on the existing North pump station and the proposed project components, noting that the project area is considered a Disadvantaged Community (DAC), making the cost share match somewhere between 0-25%. Ms. Spaletta noted that the proposed project components could be completed with the estimated 5 million dollars and property owner assessments. Ms. Spaletta went into further detail on NSJWCD's Water Rights Permit No. 10477 on the Mokelumne River, allowing them to directly divert.

Alternate Director Charlie Swimley questioned if the landowners would embrace the annual assessment costs. Ms. Spaletta advised that they would, as NSJWCD has completed other projects with a landowner's assessment model through an Improvement District, and they intend to use the same model for these proposed projects. Director Henry questioned if taking water for project during the winter months would affect the NSJWCD Water Rights. Ms. Spaletta explained how it would affect in a positive way and how the project would provide dual benefits. Mr. Zidar added that the funds could cover the project design and development costs, but noted that the DWR wants to see project completed in 3-years. Ms. Spaletta advised that NSJWCD would need technical support from GWA Consultants and County Staff for updating maps and technical aspects of the application. Director Henry questioned if the 3-year period would be a concern. Ms. Spaletta noted that the proposed project is an update and rehabilitation of an existing system that has been out of commission for a number of years.

Chairman Winn questioned if some of the water diverted is for recharge, and how well this helped NSJWCD supply water to their customers once these projects are completed. Ms. Spaletta advised that yes water would be captured for recharge and that once projects were completed, NSJWCD would still have work to do to fully meet customer water needs and achieve sustainability.

The Board further discussed the need for partnerships and joint efforts to accomplish GSA goals and meet demands of the Districts and therefore the Basin. Discussion was had on other joint effort projects. Secretary Fritz Buchman noted that groundwater banking and recharge was a top project in the Moke Wise effort funded by the state.

Ms. Chelsea Spier with the Department of Water Resources (DWR) provided some pointers and notes of items to include in the Grant Application to be more competitive.

## **B. Discussion Items:**

### **1. Financial Report**

Mr. Matt Zidar introduced the agenda item with a brief explanation, noting that the Financial Report will be provided at future meetings at the request of members. Mr. Zidar gave the floor to Ms. Alicia Connelly with San Joaquin County to provide details on the presentation slides. Ms. Connelly provided details on the GSP Development Budgets and the GSP Implementation Budget, noting specific figures related to the revenues and expenses. There were no questions or comments from the Board.

## **2. DWR Update**

Ms. Chelsea Spier with Department of Water Resources (DWR) provided a brief report with some upcoming statewide services, programs and dates, as per her provided report. Ms. Spier advised of Airborne Electromagnetic Monitoring and provided some brief details on the program. Ms. Spier noted that 2018 Land Use Data would be published by end of 2020, Satellite Data to be available spring of 2021 and CA Groundwater Update would have a draft in November. Ms. Spier additionally provided details on a DWR TAC being created for well standards updates, a CA Waterplan Webinar being held and Federal Grant opportunities, and noted that all items were linked on her report. Ms. Spier also provided reminders on the DWR Facilitation and Support Services available and completion of Census Forms.

## **III. Secretary Report:**

Secretary Fritz Buchman provided a brief report to the Board. Secretary Buchman advised the Board that after discussions with Chairman Winn, they have decided to offer an in-person option, as well as a teleconference option for Steering Committee and Board Meetings. Secretary Buchman noted that there would need to be RSVP from the GSAs in order to secure the appropriate meeting locations. Chairman Winn added that Public Health has allowed public meetings as long as the appropriate protocols are being followed. Chairman Winn added that in-person meetings offer advantages, but the virtual meetings would not be cut-off for those who prefer or require that option.

Additionally, Matt Zidar commented on the DWR Well Agreements with Stockton East Water District (SEWD) and North San Joaquin Water Conservation District (NSJWCD), noting that the County would be taking over the monitoring of those wells.

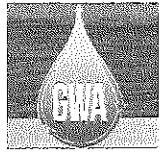

## ESJ GWA Technical Advisory Committee Meeting Notes

Friday, November 13, 2020

Meeting Called to Order at 9:02am by Mr. Matt Zidar of San Joaquin County. The meeting was held via the Microsoft Teams Platform.

Attendees noted per meeting login.

### **A. Discussion/Action Items**

#### **1. Follow up on Prior Steering Committee Meeting Discussion (Attached)**

The group reviewed the questions and issues brought forward in last Steering Committee and Ad Hoc meetings. Discussion focused on funding and financing and the scope of work under Prop 68 grant

Questions

- What does SC want consultant to work on?
- What are the questions trying to address and what discussions need to be had regarding technical materials needed to support discussions and decisions on funding (e.g.; the model)?
- Who would be a good resources for assisting in the funding and financing evaluation?

The following points were made by members.

- Our planning efforts during GSP development were limited in scope due to the deadline and budget.
- **GSA/GWA Funding**
  - Elected need to understand the SGMA laws funding provisions and what funding mechanisms are available to GSAs under SGMA.
  - GWA funding and revenue generation is limited by JPA by intent.
  - What can they/we do?
  - What are other GSAs in the basin planning to do?
  - What are other GSAs doing in other basins?
  - Probably need legal counsel to discuss what we can do under the SGMA law.
- **GWAs role**
  - Fixed based on the prior assumptions (data collection and management, facilitation/coordination, technical support, grants, reporting, liaison to DWR, etc.)?
  - Those services are a start. GWA role can be refined down the road. GWA focus on the basin, invest in Ag use projects, crediting, and basin wide pumping. How do we foster that across the basin?
  - GSAs are trying to figure out their projects.
- Water Budget, Basin Accounting and Costs



- We need to understand how to account for water and the water budget to evaluate who benefits and who pays. The model is a good tool but only part of the picture and does not account for investments made.
- A lot of basins do not have the resources to reach sustainability. Our GSP states we have the ability to reach sustainability, so why are we going to spend time discussing allocation?
- Don't want to use the term allocation for water, but the water budget could influence the allocation of costs. We do need to create accountability for who is contributing to the problem and therefore needs to be part of investing in the solution.
- How deal with free riders that won't raise revenues, invest in their own projects or contribute to solutions (physical solutions).
- Spend time in these side meetings trying to figure out the allocation of costs. Maybe spend some time and resources on determining the cost allocations and where the allocations lies.
- Allocation of costs...need to consider credits, groundwater pumped and used, surface water.
- Rose Dale Rio Bravo approach was discussed briefly
- How do we gain confidence in the modeling we have or do we need to develop something more sophisticated? The model is a start, the group has to agree on certain concepts to move forward. There are complicated and legal issues, but the group has to agree on approach to creating accountability.
- Allocating water has the implication of adjudication.
- We need to be incentive driven to make things sustainable but need to better account for water use in the basin. Need to show basin wide numbers for crediting, need better form of water use accounting.
- Need to show the value of water, value of ground water storage.
- Need to assign credit and cost, decide how to measure of benefit and assignment of costs based on impact to the basin.
- Who is liable for the hole in basin and remedy of the issue?
- Is there a basin equity assessment, is that a concept to move forward.
- Prior costs allocation was to move more towards basing it on groundwater use.
- Under law, has to be clear nexus on who benefits and who pays. But how to do that across the basin.

- a. DMS Implementation. Scope of work from W&C to move forward, task order was done.
- b. Cover the DMS implementation and planning/engineering of the west side well. Drilling will be assigned after DWR makes the full appropriation.
- c. The existing west side wells drilled by the USGS were discussed. They are still being monitored for levels but there is no equipment to test for water quality. Need to have a future discussion of the salinity monitoring program in the future.

### NEW Statewide Groundwater Level Change Report and Maps Available

The [Spring 2020 Groundwater Level Change Report](#) and accompanying maps are available on the DWR website and present a summary of groundwater level data. The report and maps include a discussion of groundwater level trends with multi-year comparisons which can assist with the development of GSPs.

### SVSim Beta Model Released

DWR has released the beta version of the [Sacramento Valley Groundwater-Surface Water Simulation Model \(SVSim\)](#) that can be used during GSP development. Instructions for use are included in the [Roadmap to Running SVSim](#) document. A calibrated version of SVSim is expected in fall 2020.

### **C2VSim Fine Grid Update Published December 2020**

C2VSimFG Version 1.0 is a historical simulation model designed to estimate regional groundwater flow throughout the Central Valley. C2VSimFG is an integrated hydrologic model application and uses demand estimates from land use and population to calculate spatially distributed groundwater pumping and recharge estimates. The updated tool includes calibration of aquifer properties and documentation. DWR will host informational webinars and a multi-day training event on C2VSimFG Version 1.0 in winter 2021.
